

Legalization of commercial and corporate documents

Required documents

1- Documents (originals and copies) to be legalized.

* Documents should initially be certified by the local Chamber of Commerce (in some cases by the [Ministry for Foreign Affairs]) and then forwarded to the Consular Section of the Embassy.

* For legalization of health certificate the original certificate is required.

2- Specification of legalization request.

3- Copy of payment into account No. 52771112515 SEB Bank

* Note : Payment in cash or by check is not acceptable.

4- Envelope for return mail with address and sufficient stamps.

* Please observe the instructions above for a quick course of legalization. Legalization will not be performed if all required documents has not been submitted.

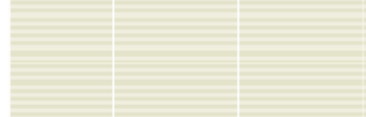
